Decisions

- 1. November 22, 2017 and December 12, 2017 were finalized and approved.
- 2. SOA 2017-07, acceptance of 2015, 2016, and 2017 Steelhead Survival Estimates as meeting the (3 Yr. Ave.) Project Performance Standard were affirmed as approved.
- 3. SOA 2018-01, Statement of Agreement on Grant PUD's Coho Obligation and Future Juvenile Survival Evaluation Schedule for Yearling Chinook, Sockeye and Steelhead was approved.

- **III.** Action Items Review from December 12, 2017 meeting (D. Rohr) All action items were completed.
- IV. Affirmation of Approval (D. Rohr) SOA 2017-07, acceptance of 2015, 2016, and 2017 Steelhead Survival Estimates as meeting the (3 Yr. Ave.) Project Performance Standard – Rohr stated that SOA 2017-07 is approved. All members, except for T. Skiles, had approved SOA 2017-07 during the December 12, 2017 PRCC meeting. During that meeting and vote, Skiles requested more time. Skiles notified Rohr by email the day following the meeting that he also approved SOA 2017-07. Accordingly, SOA 2017-07 is approved.
- V. DECISION ITEM: SOA 2018-01, Statement of Agreement on Grant PUD's Coho Obligation and Future Juvenile Survival Evaluation Schedule for Yearling Chinook, Sockeye and Steelhead - (T. Dresser, K. Murdoch) GCPUD and the Yakama Nation walked the PRCC through draft SOA 2018-01.

CCT had a question regarding of when the check-in/recalculation time was for Coho. Grant PUD indicated that as the SOA is drafted, 2023 is the decision point to decide if survival evaluations are necessary or if coho mitigation remains at 14%. CCT also asked about what happens if the survival is lower than what it is now. Grant PUD indicated that nothing in SOA precludes any member from digging into data and bringing forward new information that suggests that survival is lower than 14%. CCT asked about the term of the SOA and Grant PUD and Yakama Nation indicated that the term is actually 2032.

WDFW requested that a footnote be added to ensure that if other facilities are to be used to support the coho program that it be reviewed and approved by the PRCC Hatchery Subcommittee. Grant PUD was comfortable with that footnote addition.

After discussion, PRCC Committee members voted to APPROVE.

VI. Update Discussion of Estimating the Survival of Juvenile Spring Chinook in Lake Wenatchee (D.Rohr) – Rohr informed the committee members that a meeting was scheduled to take place immediately after today's PRCC meeting to discuss this subject. Attendees will be C. Jackson, S. Carlon, C. Dotson, P. Graf, and D. Rohr. Rohr also invited others to attend if desired.
