- II. Agenda Review (D. Rohr) Dotson requested a discussion of pinnipeds be added to the agenda.

- V. 2016 Avian Predation Presentation Allen Evans, Real Time Research; Dan Roby, USGS (C. Dotson)
 - A. Draft 2016 Avian Report Dan Roby, USGS, Don Lyons and Tim Lawes, OSU, and Ken Collis, RTR, were in attendance to make the power point presentation of the draft report, "Evaluation of Caspian Tern Management to Reduce Predation on ESA-listed Salmonids in the Columbia Plateau Region". Allan Evans, RTR, participated by conference phone.

PRCC December 13 & 14, 2016 Final Approved Meeting Minutes Background and historical activities of tern activities in the Columbia Basin and more specifically in the Columbia Plateau area were reviewed. Salmon and steelhead stocks from the Columbia Basin are listed as threatened or endangered under the U.S. Endangered Species Act, and Caspian terns nesting on the Columbia Plateau consume juvenile salmonids and are limiting the recovery of some stocks, in particular steelhead from the Snake and Upper Columbia Rivers. Accordingly, management activities are being implemented to reduce or eliminate Caspian tern nesting at Goose and Crescent islands, historically the two largest tern colonies in the region. Concurrent efforts are also in progress to create suitable tern nesting habitat outside the Columbia Basin and attract terns to nest there, including the San Francisco Bay area.

The Research Objectives of the draft report include four tasks, namely Task 1: Determine changes in colony-specific metrics and colony connectivity of Caspian terns in the Columbia Plateau region in relation to management activities at the Goose and Crescent island colonies, Task 2: Determine changes in nesting location and foraging behavior of Caspian terns in the Columbia Plateau region in relation to management activities at the Goose and Crescent Island colonies, Task 3: Determine changes in predation rates on salmonid smolts by Caspian terns in the Columbia Plateau region in relation to management activities at the Goose and Crescent Island colonies, Task 4: Determine changes in colony sizes and predation rates on salmonid smolts in the Columbia Plateau region by species of piscivorous colonial waterbirds other than Caspian terns. Activities and summary information regarding each task were reviewed, and PRCC members participated in the presentation and discussion of each. It was noted that the final draft report is expected to be completed by the end of January, 2017. Additionally, more project information can be found at www.BirdResearchNW.org.

- B. Request for NNI Funding A brief presentation was made to request consideration of NNI funding for 2017 to continue the avian predation work. Additional background was presented plus a description of the four tasks included in the 2017 proposal. The proposal will be discussed further at the next PRCC meeting in January.
