### Final Approved Meeting Minutes

<u>PURPOSE OF CALL</u> – Continued discussions regarding attempt to reach agreement regarding juvenile steelhead and summer subyearling Chinook NNI calculations and evaluation schedule.

Rohr distributed two draft SOAs prior to the call that he had received from Grant PUD which outlined two separate options to be considered regarding juvenile steelhead and summer subyearling Chinook NNI calculations and evaluation schedule. During the March 13<sup>th</sup> call, PRCC members reviewed and discussed the two options and noted and discussed some of their differences, including the two options using different study years to estimate survival. Option 1 included study years 2014 (Priest Rapids Development only), 2015, and 2016. Option 2 included study years 2015 and 2016, with 2014 not being included because of the Wanapum Dam drawdown that year due to the dam fracture that had occurred.

Each draft SOA was discussed extensively during the call, and after due consideration, a vote for each was requested. Accordingly, each of the SOAs was not approved by an identical 6-1 vote with Grant voting to approve. Discussion among PRCC members continued with a focus upon what might be an acceptable approach to all PRCC members. Several different ideas were discussed, and PRCC members agreed to

Rose and Korth volunteered to develop a draft SOA Option 3 that would include consideration of the different ideas brought forth. Next, PRCC members agreed to hold another conference call at 1:30 pm, Wednesday, March 15<sup>th</sup> to review the new draft SOA that Rose and Korth would develop. Rose and Korth also agreed to provide the new draft SOA prior to the March 15<sup>th</sup> conference call to allow adequate time for PRCC member review.
