## **Final Approved Meeting Minutes**

PURPOSE OF CALL – Consideration of SOA 2017-02, Statement of Agreement on Juvenile Steelhead and Summer Subyearling Chinook NNI Calculations and Evaluation Schedule.

**BACKGROUND** – A PRCC conference call was held on March 15<sup>th</sup> to continue discussion and consideration of Statements of Agreement on Juvenile Steelhead and Summer Subyearling Chinook NNI Calculations and Evaluation Schedule. The draft SOA option 3, prepared by Rose and Korth, and the draft SOA option 1A prepared by Grant PUD were reviewed and discussed by the PRCC. After both options were discussed extensively, PRCC members agreed to include a survival study in 2017 as outlined in option 1A, plus Grant PUD agreed to additional edits which were suggested for option 1A. There was agreement that Grant PUD and Rose would work together on a new draft SOA for consideration by the PRCC during the next conference call scheduled for Friday, March 17<sup>th</sup> at 1:30 pm.

On May 16<sup>th</sup>, the draft SOA 2017-02, Statement of Agreement on Juvenile Steelhead and Summer Subyearling Chinook NNI Calculations and Evaluation Schedule, developed by Rose and Grant PUD, was distributed to PRCC members for review and consideration. Accordingly, during the conference call on March 17<sup>th</sup>, after review and discussion, SOA 2017-02 was approved by PRCC vote.
