- IV. Action Items Review from May 27, 2015 Meeting (D. Rohr) All action items were reviewed.
- V. Potpourri (D. Rohr)
 - A. FPAC Activities Discussion was held regarding a memo that was potentially coming out from FPAC regarding PRCC activities. From the May 27th meeting Rohr's suggestion was to wait and see if anything was received from FPAC before having further discussion. Rohr stated he has not received anything, and to his knowledge PRCC members have received nothing as well. Comment was made that if FPAC has questions regarding PRCC activities, they should work with their respective PRCC committee member to address them. Everyone feels that FPAC's questions may have been answered. Carlon felt that PRCC committee members have responded to FPAC, and there is nothing more to do at this time.
