Action Items from June 12, 2014 Meeting:

- 1. Duvall will request a breakdown of appraisal cost from Strickland.
- 2. Duvall will talk to Grant PUD staff in the real estate department to see if the Natapoc appraisal cost seems reasonable.
- 3. HSC members will review the Natapoc appraisal, determine if a review appraisal needs to be conducted, decide to approve or deny purchase of the three properties, and email vote to Rohr by June 26th.
- 4. Duvall will discuss the \$50,000 for 5 years offer to fund the White River Staff Gage, with Mike Anderson, WDOE.
- 5. Rohr will notify Fleming that the HSC has requested additional time to review the CDLT proposed Lower Nason Creek project.
- 6. Rohr will send Mike Kaputa, Chelan County Natural Resources a letter notifying him that the \$160,000 encumbered for the Nason Creek LWP Flood Plain Reconnection Project, has been terminated.
