Decision Summary:

- 1. Because landowners of the Tyee property rejected language of the conservation easement as proposed by the PRCC Habitat Subcommittee (HSC), all members of the HSC agreed that the conservation easement be pulled off the table.

Final Meeting Minutes

I. Tyee Ranch Project – Because landowners of the Tyee property rejected language of the conservation easement as proposed by the PRCC Habitat Subcommittee (HSC), all members of the HSC agreed that the conservation easement be pulled off the table. II. Natapoc Habitat Restoration Properties Strategic Acquisition, Brandon Rogers, Yakama Nation – Duvall explained that he contacted Fred Strickland because the Yakama Nation asked that the Natapoc hazmat appraisal be deferred to him. Strickland told Duvall that he contracts hazmat appraisals out because he doesn't do them, so Duvall asked Strickland to provide a cost estimate. If the hazmat appraisal estimate is less than \$5,000, it will be added to Strickland's scope of work within his \$20,000 purchase order. If it's more than \$5000, Carlson will check with Brandon Rodgers to see if he has funds to pay for the hazmat appraisal.
